THE CARPENTRY SHOP (0-2205B)

*NYS General Municipal Law Section 239 requires a vote of a 'majority plus one' of your agency to act contrary to the above findings. The review undertaken by the Rockland County Planning Department is pursuant to, and follows the mandates of Article 12-8 of the New York General Municipal Law. Under Article 12-8 the County of Rockland does not render opinions, nor does it make determinations, whether the item reviewed implicates the Religious Land Use and Institutionalized Persons Act. The Rockland County Planning Department defers to the municipality forwarding the item reviewed to render such opinions and make such determinations if appropriate under the circumstances.

In this respect, municipalities are advised that under the Religious Land Use and institutionalized Persons Act, the preemptive force of any provision of the Act may be avoided (1) by changing a policy or practice that may result in a substantial burden on religious exercise, (2) by retaining a policy or practice and exempting the substantially burdened religious exercise, (3) by providing exemptions from a policy or practice for applications that substantially burden religious exercise, or (4) by any other means that eliminates the substantial burden.

Proponents of projects are advised to apply for variances, special permits or exceptions, hardship approval or other relief.

Pursuant to New York State General Municipal Law §239-m(6), the referring body shall file a report of final action it has taken with the Rockland County Department of Planning within thirty (30) days after final action. A referring body which acts contrary to a recommendation of modification or disapproval of a proposed action shall set forth the reasons for the contrary action in such report.

Hi Debbie,

Let me address each question in order:

Are plumbing plans available?

I have reached out to the owner of the building to see if they can provide me with such plans. We have not changed or added anything to the existing structure. Plumbing has not been touched in anyway. Any kitchen or bathrooms were already here before we arrived. My assumption would be that the plumbing was part of the original CO for this building or a renovation that occured way before we got here. I will forward any information I receive from the owners.

Are there floor drains present in the shop?

No, there are no drains in the shop and therefore no accidental discharge into the town sewer system. Also, I feel it's important to note that we are moving to all natural finishes. We are using a product called Odies Oil which is 100% food safe and solvent free. Here is the <u>link to safety sheets</u>. We are making this move because it will be better for the safety of our employees, the community and sustainability of our planet. We are also looking into new water base finishes that we might consider using should they meet our new standards.

Is there any source of process related discharge which will reach the system (e.g. cleaning of staining tools, water used in cutting machines, etc.)?

Since we have moved to this new product all of the stains are actually finely ground pigments. The pigments are mixed into the odie's oil and applied with a fine scotch brite pad and wiped off with a clean cotton terry cloth towel. Nothing is cleaned in the sink. These items have a one time use. Also we do not own any machinery that requires water to cut.

I hope I have answered all of your questions and addressed any concerns that you may have. As soon as I hear back from the owner of the building I will forward the correspondances.
