**RE: Rivian Automotive Sign Plan:** The application of PG-OE 800 Bradley Hill Road Owner, LLC., owner, for the review of a Sign Plan at a site to be known as “**Rivian Automotive Sign Plan**” in accordance with Article 16 of the Town Law of the State of New York and Chapter 2 of the Code of the Town of Orangetown. The site is located at 800 Bradley Hill Road, Blauvelt, Town of Orangetown, Rockland County, New York, and as shown on the Orangetown Tax Map as Section; 65.18, Block 1, Lot 3 in the LI zoning district.

Heard by the Architecture and Community Appearance Board of Review of the Town of Orangetown at a meeting held **Thursday, May 16, 2024** at which time the Board made the following determinations:

**FINDINGS OF FACT:**

1. The Board found that the applicant proposed to place two lighted signs on the Rivian Automotive Building. One of the signs would be north facing above the proposed interior automobile entrance / exit. The other sign would be west facing and overlook the parking lot on the west side of the building. The signs would both:
  - o be white and contain the corporate logo in red, followed by the words “RIVIAN” in black capital letters; and
  - o be lit from dawn to 12:00 am.
2. The Board found that the modern look of the signs would fit the modern look of the proposed building.

The hearing was then opened to the Public.

There being no one to be heard from the public, the Public Hearing portion of the meeting was closed.

**DECISION:** In view of the foregoing and the testimony before the Board, the application was **Approved as Presented**.
