**RE: Letter of Commitment for Electric Road Vehicle, Electric Landscaping Equipment  
& Electric Non-Road Vehicle**

To Whom It May Concern:

May this serve as the Letter of Commitment for the Town of Orangetown to apply for NYSERDA's Clean Energy Communities Action Grant for achieving a 1 Star and 2 Star Designation by becoming a Bronze-Certified Climate Smart Community. Through this Letter of Commitment, I, Supervisor Teresa M. Kenny, the top official of the Town of Orangetown, authorize the Town of Orangetown to submit this grant application.

I also certify that all of the information contained in this application is true, correct and complete to the best of our knowledge and belief. I am proud of my Town's leadership in becoming a Bronze-Certified Climate Smart Community and we look forward to completing more High Impact Actions set forth by NYSERDA.

Previously, the Town was awarded the \$5,000 Designation Grant for completing four High Impact Actions: Clean Fleets, Energy Code Enforcement Training, LED Street Lights, and Unified Solar Permit. In addition, the Town was awarded a \$50,000 grant for adopting the NYStretch Energy Code. Presently, the Town earned a 1 Star and 2 Star designation for becoming a Bronze-Certified Climate Smart Community and became eligible for a \$10,000 and \$125,000 grant, respectively, thus bringing our point total to 3,200.

With these awards, the Town of Orangetown intends to purchase our second electric road vehicle, a Ford Mustang Mach-E, which will replace a damaged 2015 Ford Explorer used by the Town's Parking Meter Department. Our Parking Meter Department maintains all of the 410 parking meters and municipal lots in the Pearl River Parking District. With a yearly mileage of approximately 5,250 miles, an electric vehicle will contribute to lowering greenhouse gas emissions in the Town of Orangetown. Additionally, it will demonstrate the Town's commitment to greener alternatives and hopefully inspire our residents to do the same.

The Town received a quote for the 2024 Ford Mustang Mach-E for \$51,726. Please see table on Page 3 for the breakdown of grant monies.

The Town also intends to purchase electric landscaping equipment and a utility (non-road) vehicle for the Parks and Recreation Department (see table of equipment on page 3). They will be used to replace our gas-powered equipment, which will significantly reduce greenhouse gas emissions, and improve air and noise pollution. The two electric riding mowers with a rear discharge will be used extensively throughout the Orangetown Park system to cut approximately 80 acres of land on a weekly basis. The quieter operation will be appreciated by our park neighbors as they will make less noise and eliminate exhaust. The small self-propelled mower will be used in park areas that are not accessible to the larger ride-on mowers.


Additionally, the Town plans to purchase an electric chainsaw, (see table) which will be used for tree pruning and post-storm cleanup of downed trees. The electric blower will primarily be used to blow off athletic courts throughout the year. This unit will operate much quieter than our 2-cycle gas blowers and will benefit the community as some of our athletic courts are in residential areas. We plan to purchase extra batteries and chargers, which will allow more time with each piece of equipment, increasing efficiency and decreasing our dependence on gas-powered equipment.

Lastly, the utility vehicle will be used by maintenance staff for garbage and recycling pickup (see table). This smaller, electric vehicle is much safer to operate around the public than a full-size pickup truck and is a zero-emission vehicle.

I wholeheartedly support this application for the Town of Orangetown's electric road vehicle, electric landscaping equipment and an electric non-road vehicle. These purchases will further demonstrate the Town's leadership in advancing our sustainability initiatives.
