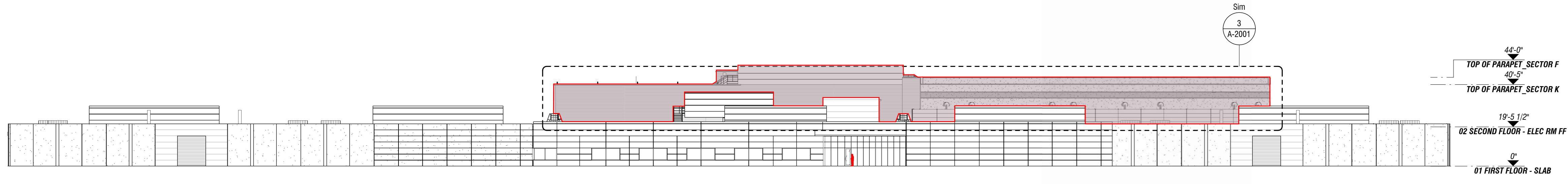

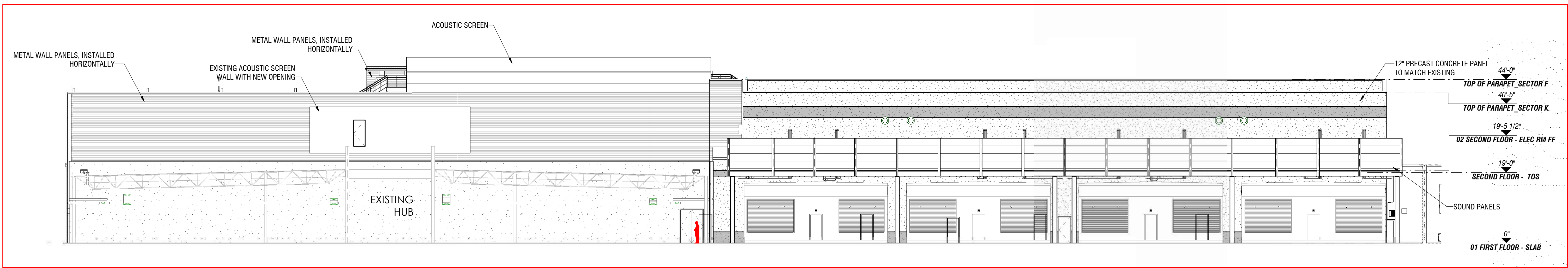

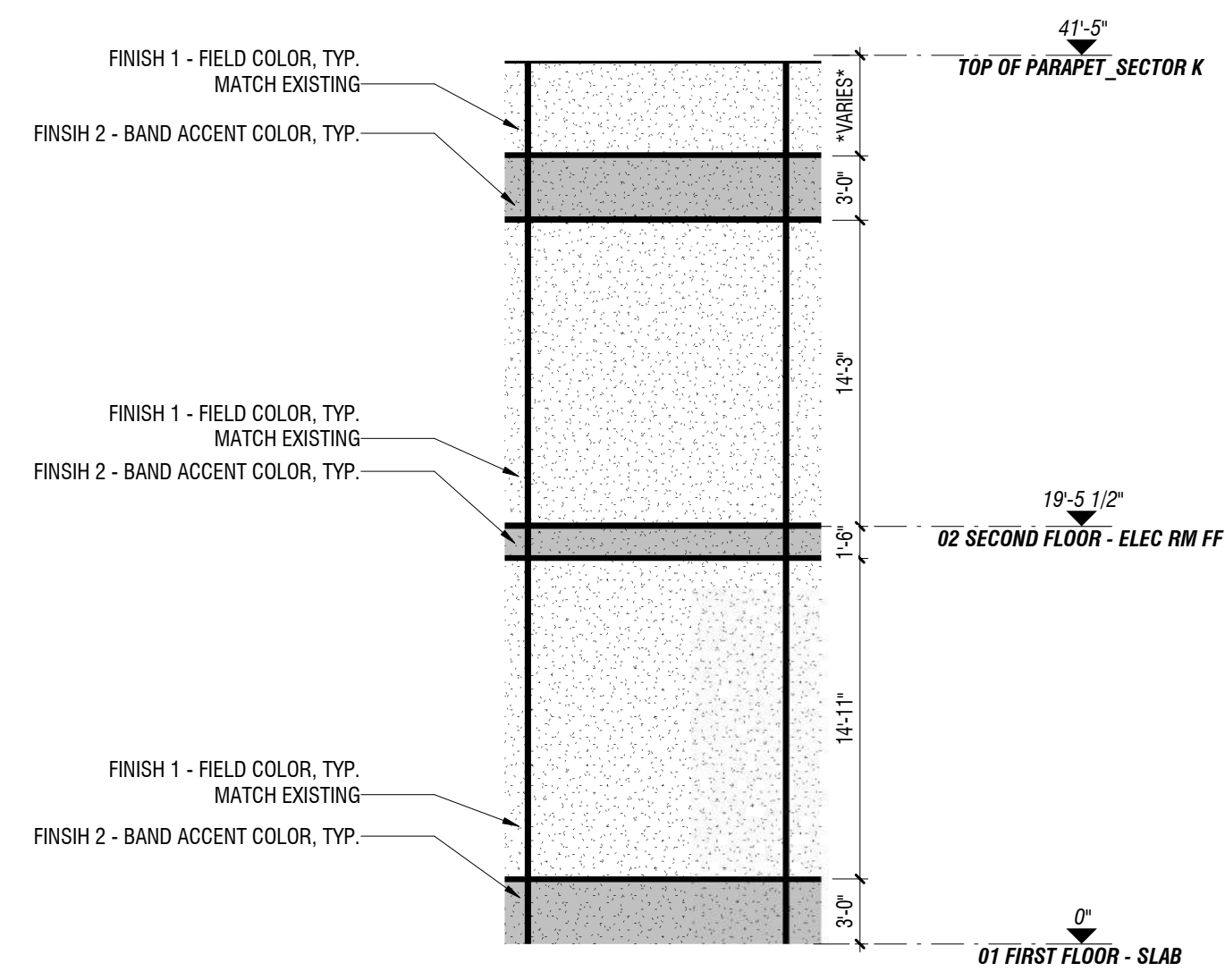
2 EXTERIOR ELEVATION NORTH EXISTING & NEW BUILD PHASE III BEYOND

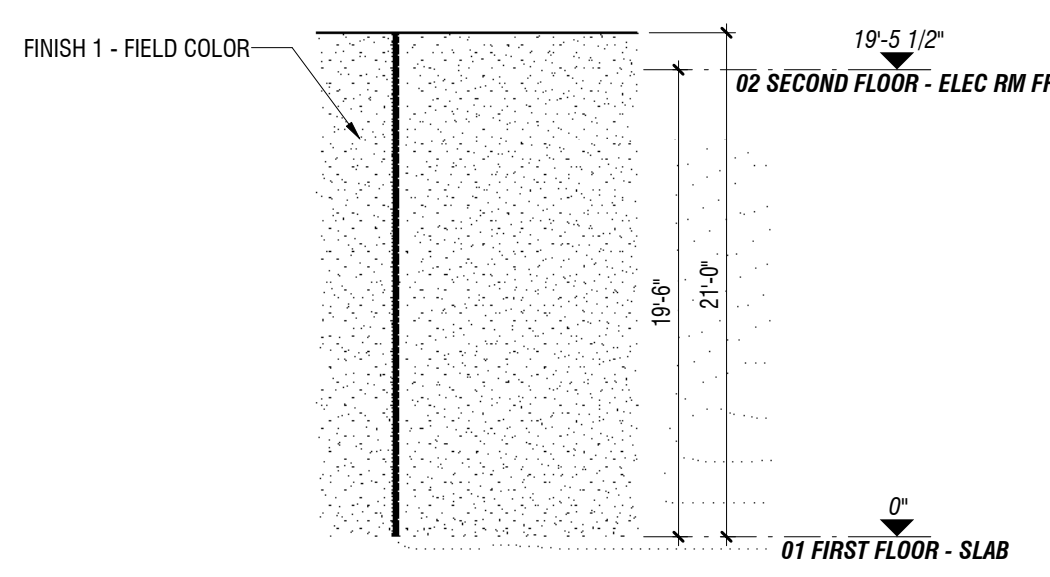

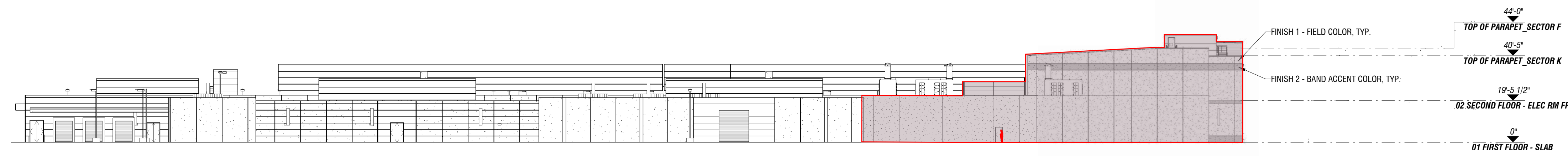

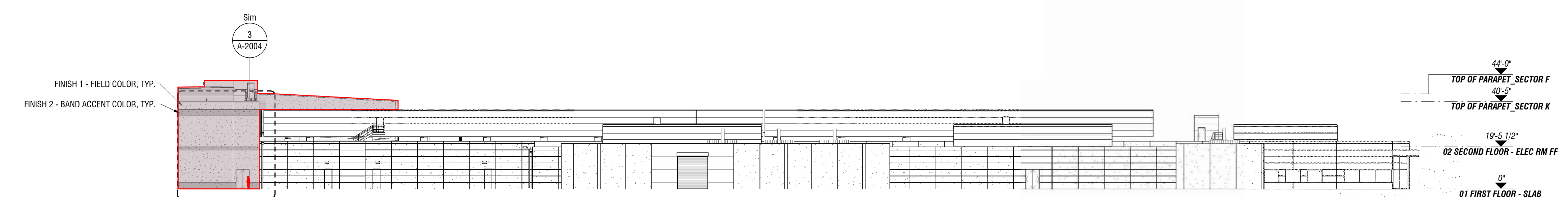

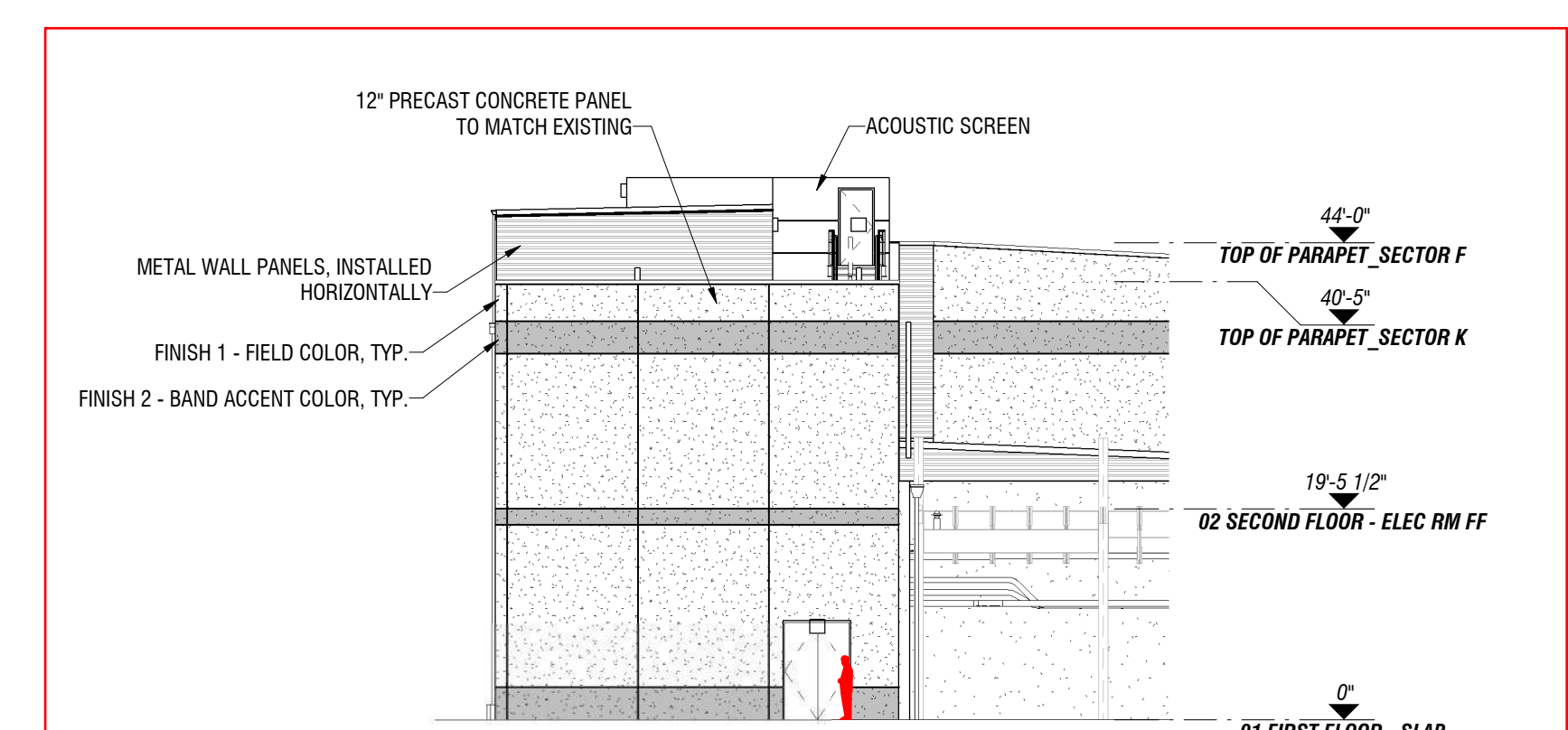
