The site is located at 29 Corporate Drive, Orangeburg, Town of Orangetown, Rockland County, New York, and as shown on the Orangetown Tax Map as Section 73.19, Block 1, Lot 8 in the LIO zoning district.

The second sign is an 8'-0" x 4'-0" double sided non-illuminated free-standing sign, yellow background with red and white logo. The existing bushes shall be kept trimmed.
