

FINDINGS OF FACT:

1. The Board found that the applicant is seeking to replace the roof with metal shingles that are charcoal gray in color and manufactured by Union Corrugating, or equal.
2. The Board found that the applicant is seeking to replace the siding with WPC Vinyl wall siding panel, or equal, that is light gray in color.
3. The Board found that the window trims would be replaced with black window trims.
4. The Board found that the windows would be replaced with Anderson white windows, or equal.
5. The Board found that the applicant would place the split air conditioning units in the back of the site and not be visible from the road.

The hearing was then opened to the Public.

FINDINGS OF FACT:

- A. The Board found that the proposed changes are part of a rebranding which consists of the following:
1. The Board found that below the stand-alone logo sign adjacent to the street, the applicant is proposing to place two double sided signs that are 43.375" by 56" inches. The sign closest to the road will display the digital pricing of the signs. While the sign furthest from the road will display the words "Food Mart". The signs will be LED illuminated, appear dark blue in color during the day and appear black in color at night. The material would be Polycarbonate Lexan Faces, or equal, manufactured by Everbrite.
 2. The Board found that the canopy covering the gas dispensers would be a Polycarbonate Lexan Faces material, or equal, and be manufactured by Pro Signs, and be rebranded as follows:
 - The front elevation will be blue in color and display the words "SUNOCO" in white font and all capital letters. The front elevation will also have a yellow arrow like logo pointing away from the text outlined by a lighter shade of blue.
 - The rear elevation will be dark blue in color with a lighter blue color along the bottom of the sign
 - The left and right elevation signs will be dark blue in color with lighter shades of blue towards the center. At the center of the sign will be the Sunoco logo.
 3. The Board found that the dispensers would be a Polycarbonate Lexan Faces material, or equal, and be manufactured by Pro Signs, and be rebranded as follows:
 - The Sunoco Logo at the top of them surrounded by a dark blue backed sign.
 - The bottom of the dispensers will display the words "SUNOCO" in all capital letters and white text. It will be backed by a blue background.
 - The side facing top of the dispensers will display the words "SUNOCO" in all capital letters and white text. It will be backed by a blue background.
