## **FINDINGS OF FACT:**

- 1. The Board found that Key Bank is going through a nationwide rebranding and that is reflected in the presented plans. The applicant noted that the current signage is outdated.
- 2. The Board found that the applicant plans to replace all the current signage and awnings, with updated signage that has the same length width and height dimensions as the existing signage.
- 3. The Board found that the applicant plans to place a double-sided sign with the words "KeyBank" in black above a red key icon consistent with the corporate demands and placed on a white signage with a red stripe along the bottom. The sign would be LED illuminated, be mounted on a brick base and be located on the northwest lawn of the property.
- 4. The Board found that the north and west facing signage above the respective red awnings would consist of the words "KeyBank" in black preceding corporate key logo in red. The sign would be powered by LED lights using the same lighting schedule as is currently in effect.
- 5. The Board found that all six of the existing awnings would be replaced with awnings that would be manufactured by Cooley Wheathertyte "dark red" in color, or equal. Contain square aluminum tube frames that are dark bronze in color and have open bottoms and frames. Three of the awnings would be corner wrapped, while the other remaining three would be straight.
