- 5. The Board found that the storefront sign would have a black border trim around the perimeter.

- 11. The Board found that the words "New American Cuisine" will be depicted below where it says "BAR & GRILLE". It will be 2" IN in height in FFFFFF white in color manufactured by Hispania Signs, or equal.
