 - One of the signs will be in the center of the building with a length of 366" IN and a height of 50" IN. Containing the Initials "HB" displayed in a 3-dimensional manner with a black and white outline with green text, with 4" depth, 50" IN height and a 77.5" IN width. To the right of the "HB" logo, this sign would display the words "Hauser Bros., INC" in a 3-dimensional manner with a black and green outline and white text, have a 4" IN depth and a 1" IN retainer and have 255" IN length and be 26.26" IN in height. Below the "Hauser Bros., Inc" portion of the sign would be in black text depicting the the words "PLUMBING & MECHANICAL" in all capital letters with the text "Since 1953" in cursive text, with the dimensions being 239" IN in length and 11" IN in height.

FINDINGS OF FACT:

- 1. The Board found that the applicant plans to place a post monument double sided light box sign on the front lawn with double posts. The sign would contain a white background displaying the words "Muse Beauty" in black cursive text with the business logo of an open blue scissor surrounded by dark pink plant like icons directly between the words "Muse" and ""Beauty". Below that on the sign in a very small black text would display "BY GIANNA'S HAIR STUDIO". The bottom portion of the sign would be a blue strip with the address of the location depicted in white text. The sign would be 24" IN in height and length would be 48" IN in length.
- 2. The Board found that the applicant plans to place a blade light box double sided sign hanging off the side of the building. The sign would contain a white background displaying the words "Muse Beauty" in black cursive text with the business logo of an open blue scissor surrounded by dark pink plant like icons directly below the aforementioned text". Below the logo on the sign in a very small black text would display "BY GIANNA'S HAIR STUDIO". The sign would be 72" IN in height and length would be 480 IN in length.
