PROPOSE AMENDMENT CHAPTER 39 (VEHICLES AND TRAFFIC), ARTICLE I (VEHICLE AND TRAFFIC REGULATIONS) OF THE CODE OF THE TOWN OF ORANGETOWN

As amended, additions are underlined.

Be it enacted by the Town Board of the Town of Orangetown as follows:

Section 1 – Legislative Findings, Objectives and Purpose of this Local Law:

The Town of Orangetown Traffic Advisory Board, having investigated issues related to congestion and safety in the Hamlet of South Nyack, recommends the Town Board adopt the local law amending the Town Code, to prohibit parking on the north side of Gesner Avenue, from the eastern-most pavement edge extending for 102 feet west, and south side, from the eastern-most pavement edge extending for 338 feet west. Having held a public hearing on the matter, the Town Board finds the Prohibition on Parking is necessary for traffic safety. The time limitation parking on Gesner Avenue will also be removed.

Additionally, the Orangetown Traffic Advisory Board, having investigated issues related to congestion and safety in the Hamlet of Tappan, recommends the Town Board adopt the local law amending the Town Code to prohibit parking on the east side of Brandt Avenue between Old Tappan Road and Main Street.

Section 2 – Chapter 39 (Vehicles and Traffic), Article I (Vehicle and Traffic Regulations), §39-5 of the Code of the Town of Orangetown entitled "Prohibition of stopping, standing or parking in specified places", shall be amended so as to revise the following subsection "20" to paragraph "M" of Section 39-5, and, as amended, shall read as follows:

39-5. **Prohibition of stopping, standing, or parking in specified places**. Except when necessary to avoid conflict with other traffic or in compliance with law or the directions of a police officer or official traffic control device, no person shall, within the limits of the Town of Orangetown:

In the Hamlet of South Nyack, parking in the following locations is prohibited:

Gesner Avenue, north side, from the eastern-most pavement edge extending for 102 feet west, and south side, from the eastern-most pavement edge extending for 338 feet west.

Section 3 – Chapter 39 (Vehicles and Traffic), Article I (Vehicle and Traffic Regulations), §39-7 of the Code of the Town of Orangetown entitled "Time limitation on parking" shall be amended so as to repeal subsection (A)(5)(i), and, as amended, shall read as follows:

39-7

The parking or standing of vehicles for a period of longer than two hours is hereby prohibited in any of the following locations:

In the Hamlet of South Nyack:

Intentionally deleted.

Section 4 – Chapter 39 (Vehicles and Traffic), Article I (Vehicle and Traffic Regulations), §39-6 of the Code of the Town of Orangetown entitled "Prohibition of parking on designated highways", shall be amended so as to revise the following subsection "8" to paragraph "E" of Section 39-6, and, as amended, shall read as follows:

39-6 **Prohibition of parking on designated highways.** The parking or standing of vehicles in any of the following locations is hereby prohibited:

In the Hamlet of Tappan:

On the east side of Brandt Avenue between Old Tappan Road and Main Street.

Section 5- Chapter 39 (Vehicles and Traffic), Article I (Vehicle and Traffic Regulations), §39-7 of the Code of the Town of Orangetown entitled "Time limitation on parking", shall be amended so as to revise the following subsection "d" to paragraph "2" of Section 39-7D, and, as amended, shall read as follows:

39-7

The parking or standing of vehicles for a period of longer than four hours is hereby prohibited in any of the following locations:

In the Hamlet of Tappan:

On the westerly side of Brandt Avenue between Old Tappan Road and Main Street.

Section 6. Authority

This proposed Local Law is enacted and adopted pursuant to NYS Municipal Home Rule Law §10, and in accordance with the procedures prescribed in NYS Municipal Home Rule §20.

Section 7. Severability

If any section, subdivision, paragraph, clause or phrase of this Local Law shall be adjudged invalid, or held to be unconstitutional, by any court of competent jurisdiction. any judgment or order made thereby shall not affect the validity of this Local Law as a whole, or any part thereof, other than the part or provision so adjudged to be invalid or unconstitutional.

Section 8. Effective Date

This Local Law shall take effect upon publishing and posting a copy in the manner prescribed by applicable laws, and upon filing a copy with the NYS Secretary of State

WHEREAS, the Town Board has reviewed the qualifications and experience of Richard Oliver, currently the Deputy Director of OBZPAE, and finds it is in the best interest of the Town to appoint Richard Oliver as Acting Director of OBZPAE on a temporary basis, until further action of the Town Board; and,

WHEREAS, the Town Board acknowledges that Richard Oliver, as Acting Director of OBZPAE, shall have all authority, duties and responsibilities of the position of Director, as set forth in the Orangetown Town Code; and,

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Orangetown hereby appoints Richard Oliver, a resident of the State of New York, as Acting Director of OBZPAE, effective April 7, 2025, nunc pro tunc, until further action of the Town Board, to be compensated at an annual salary of \$170,000 during the time he serves as Acting Director; and,

BE IT FURTHER RESOLVED, that Richard Oliver, as Acting Director, shall have all authority, duties and responsibilities of Director of OBZPAE, as set forth in the Orangetown Town Code.

WHEREAS, pursuant to Section 75 of the New York Civil Service Law, an employee is entitled to a hearing on any disciplinary charges and specifications preferred against him or her; and

WHEREAS, the Town of Orangetown filed a Notice of Discipline against Employee No. 4153 on April 3, 2024, which contained five (5) disciplinary charges; and

WHEREAS, the Hearing Officer found Employee No. 4153 guilty of all five (5) charges, including all specifications, preferred against him in the Notice of Discipline; and

WHEREAS, the Hearing Officer recommended the appropriate penalty for Employee No. 4153 be dismissal from service; and

WHEREAS, the Town Board was designated, pursuant to Resolution No. 160, dated March 25, 2025, to review and consider the record of the hearing, including the Hearing Officer's Decision and all exhibits as made part of the Record, and issue a determination as to the disciplinary charges, and if appropriate, an assignment of penalty;

WHEREAS, the Town Board members acknowledge receipt, have reviewed and considered the Record of the Hearing, including the report and Recommendation of the Hearing Officer and all exhibits as made part of the Record,

RESOLUTION NO. 193

APPLY FOR FUNDING / FY2026 COMMUNITY PROJECT FUNDING / IMPROVED PEDESTRIAN INFRASTRUCTURE FOR MIDDLETOWN ROAD CORRIDOR PROJECT SIDEWALKS, CURBS & DRAINAGE IMPROVEMENTS

WHEREAS, the Town of Orangetown, after due consideration, has determined that it is desirable and in the public interest to undertake the necessary activities for the submittal of a grant application under the FY2026 Community Project Funding for the "Improved Pedestrian Infrastructure for Middletown Road Corridor" project; and,

WHEREAS, the Town is seeking up to \$1,500,000 in funding for sidewalks, curbs and drainage improvements for the North Middletown Road corridor between Brightwood Avenue and Crooked Hill Road in Pearl River; and,

WHEREAS, the North Middletown Road corridor is home to many shops and restaurants, multifamily housing, schools, a church as well as the entrance to the downtown business district in Pearl River which includes four commuter bus lines, one local bus line and a rail line; and,

WHEREAS, FY2026 Community Project Funding assistance will enable the Town to improve pedestrian facilities allowing students, the elderly, consumers and commuters to walk to their destinations instead of using vehicles, thus contributing to lower greenhouse gas emissions; and,

NOW THEREFORE BE IT RESOLVED, that the Town Board authorizes and directs the Town Supervisor to submit an application to the FY2026 Community Project Funding program for the "Improved Pedestrian Infrastructure for Middletown Road Corridor" project and to execute all documents necessary for the implementation of this work relating to the financial and/or administrative processes of the grant program.

AUTHORIZATION FOR A THIRD AMENDMENT TO CONTRACT OF SALE PURCHASE OF REAL PROPERTY LOCATED AT 149-157 PIERMONT AVE., S. NYACK, NEW YORK / LIVING CHRIST CHURCH

WHEREAS, the Town Board by resolution No. 2024-328 adopted on June 25, 2024, the Town Board authorized the Supervisor to execute Contract of Sale ("Contract") with the LIVING CHRIST CHURCH OF THE CHRISTIAN AND MISSIONARY ALLIANCE, INC. f/k/a SIMPSON MEMORIAL CHURCH, Inc. (the "Seller") for the Town to purchase a certain parcel of real property located in the Town of Orangetown, County of Rockland, and State of New York, containing approximately 6.5 acres, and having the Tax Map Identification Number: 66.54-2-11 (the "Property"), under terms and conditions set forth more fully in the Resolution; and

WHEREAS, the Resolution was subject to permissive referendum, which was duly advertised by the Town Clerk as required by law, and said Resolution took effect thirty days after its adoption, since no petition seeking a referendum was filed with the Town Clerk and the Contract having been fully executed by the parties as of July 31, 2024, and

WHEREAS, on February 25, 2025 the Town Board, in Resolution No. 2025-120 authorized the Town Supervisor to execute a First Amendment to Contract of Sale

recognizing that the Seller was undertaking to have further tests conducted at the property by Castlton Environmental Consultants, LLC (Castlton) with respect storage tanks, and the Town agreed that the Seller was authorized to use part of the down payment to pay for the costs of said testing, with the Town receiving a credit in the purchase price at closing, and

WHEREAS, on March 25, 2025 the Town Board, in Resolution No. 2025-159 authorized the Town Supervisor to execute a Second Amendment to Contract of Sale authorizing the payment of additional sums towards the down payment, to be held in escrow by counsel for the seller and to be credited to the Town at closing, and which resolution authorized release thereof to cover the costs of remediation at the site as set forth more fully therein, which cost is to be borne by the seller and,

WHEREAS, the cost for remedial measures as set forth in Resolution No 2025-159 has exceeded the amounts that are being held in escrow by counsel for the seller, and

WHEREAS the seller has requested that the Town submit an additional down payment in the amount of \$40,000.00, which seller shall be authorized to access so that seller can undertake the remedial measures, with the purchase price being reduced by any amounts of the down payment being used for such testing and remedial measures, and which agreement is to be memorialized by a Third Amendment to the Contract setting forth the terms and conditions of such additional testing, payments and credits, as well as extension of certain time periods in the Contract, which terms are set forth more fully in the proposed Amendment,

NOW THEREFORE BE IT RESOLVED that the Supervisor for the Town of Orangetown (the "Supervisor") or her designee is hereby authorized to execute the Third Amendment to the Contract of Sale as proposed, on the terms and conditions detailed therein; and to take any such actions, including but not limited to the execution of documents, as are necessary to implement the terms and conditions of said Third Amendment to Contract of Sale.

WHEREAS, the South Orangetown Ambulance Corps, owner of certain property located at 70 Independence Avenue, Tappan, New York (Tax Lot Section 74.18, Block 3, Lots 39 and 40), has applied for and received site plan approval from the Town of Orangetown Planning Board for the project known as "South Orangetown Ambulance Corps Site Plan" on said property, and

RELEASE OF VIRGINIA HOMES SUBDIVISION PERFORMANCE BOND AND LETTER OF CREDIT / WILLIAM STREET & SPARKILL AVENUE, SPARKILL, NEW YORK

WHEREAS, the owner of certain property located at William Street and Sparkill Avenue, Sparkill, New York (Tax Lots 77.08 Block 5 Lots 33.2 and 36) received subdivision and site plan approval from the Town of Orangetown Planning Board for said property for the project known as "Virginia Homes Subdivision"; and

WHEREAS, pursuant to Planning Board approval, the owner was required to post a performance bond in the amount of \$106,920.00 to ensure the construction and completion of certain public improvements within the subdivision; and

WHEREAS, the owner submitted a fully executed Performance Bond dated October 22, 2015, along with a Letter of Credit issued by Bank of America, N.A., No. 68120759 in the amount of \$106,920.00 naming the Town of Orangetown as beneficiary, as collateral for such Performance Bond, which Bond and Letter of Credit were accepted, received and filed with the Office of the Town Clerk (Town Board Resolution No. 2015-483); and

WHEREAS, the Planning Board, after receiving recommendations from the Department of Environmental Management and Engineering (DEME) and the Superintendent of Highways, voted pursuant to PB#25-17 to recommend to the Town Board that the above-referenced Performance Bond and Letter of Credit be released; and

WHEREAS, the Town Attorney's Office also recommends that the abovereferenced Performance Bond and Letter of Credit be released.

NOW, THEREFORE, BE IT RESOLVED, upon the recommendation of the Planning Board, the Town Highway Department, DEME, and the Town Attorney's Office, the Board hereby authorizes the release of the Virginia Homes Subdivision Performance Bond dated October 22, 2015 and the accompanying Letter of Credit issued by Bank of America, N.A., No. 68120759 in the amount of \$106,920.00.

Good evening,

I am here again tonight to ask that the Orangetown Law permitting parking on the shoulder of South Boulevard, which is found at Chapter 39-3, be amended to allow such parking in the areas where it is actually needed. The definition of the area where such is permited states as follows:"...from 600 feet north of Welles Lane continuing 375 feet further North. "Strangely, Welles Lane is a private driveway located in Upper Grandview. Further, it is not stated whether this measurement begins in the center of the junction with South Blvd., the edge of the shoulder, etc.? The definition in its totality appears to eliminate the areas of South Blvd. in which parking on the shoulder is most practiced and needed.

South Blvd. is essentially located on the side of a very steep cliff-like area through most of its course. Some of the houses on the eastern side of South Blvd. in this section have no off street parking. Others do have off street parking at the foot of a very, very steep driveway which is difficult to navigate in winter conditions and consequently park on the shoulder when snow is forecast. In addition, because of the steepness of the terrain, many people in this area on both sides of the street use the eastern shoulders for overflow parking.

It has been suggested that we should simply not worry about the law. It probably won't be enforced. But an informal, quasi legal approach is really not appropriate.

Accordingly, I ask you to make a small change in the language that defines the area in which such parking is needed. At Chapter 39-3, A, 5, a, 5, strike the phrase " from 600 feet north of Welles Lane continuing 375 feet further north" and replace it with,

"from the center of the junction of Upland Drive and South Boulevard, southwards to the former village line."

With regards to Gesner Ave. ,since the law is being modified, an exception to no parking in the immediate area of the Gesner Avenue Riverfront Park should be made that provides for a disabled parking space. This would bring it into compliance with both New York State and Federal law concerning access for the disabled.
