RE: Island Breeze Grill and Café Plans: The application of Sean Nicholson, applicant, for Frank Rinaldi, owner for the review of Structure Color and Sign Plans at a site known as "Island Breeze Grill and Café Plans", in accordance with Article 16 of the Town Law of the State of New York and Chapter 2 of the Code of the Town of Orangetown. The site is located at 326 Convent Road, Blauvelt, Town of Orangetown, Rockland County, New York, and as shown on the Orangetown Tax Map as Section 69.20, Block 2, Lot 33 in the CS zoning district.

Heard by the Architecture and Community Appearance Board of Review of the Town of Orangetown at a meeting held **Thursday, March 21, 2019** at which time the Board made the following determinations:

Sean Nicholson appeared and testified. The Board received the following items:

- A. A Narrative and Specification sheet submitted by the applicant.
- B. Sign Plan prepared by Hudson Valley Sign Studio dated January 18, 2019.
- **C.** Copy of the Building Permit Referral, dated January 30, 2019 prepared by Rick Oliver, Building Inspector.

#### FINDINGS OF FACT:

- 1. The Board found that the applicant proposed two signs consisting of a new face covering over an existing internally illuminated wall sign box and a new face covering on an existing pole sign. The pole sign would be shared with an adjacent business; Tua Cocina Mexicana.
- 2. The Board found that the proposed refaced sign on the building would be 24 inches by 170 inches; white background, black lettering and a logo in black and gold/tan color. Island Breeze Grill and Café colors of the sign would have a white background with black and gold/tan logo. The Tua Cocina Mexicana section of the sign would have a white background with black and red lettering with gold, green, red and gold/tan logo. The pole sign would measure 40 inches by 72 inches, as noted on the submitted plans.
- **3.** The Board found that the pole and sign frame needed to be repainted either black or brown.
- 4. The Board found that the building color, Caribbean Blue is acceptable.

There being no one else to be heard from the public, the Public Hearing portion of the meeting was closed.
