Other Business: Subaru Service Building; Roof top equipment screening; ACABOR #17-09, Section 70.14, Block 4, Lot 12, April 20, 2017. The Board continued the hearing from the April 19, 2018 meeting, in which revised plans and material information were requested. Gary Garrett, a representative of Subaru, submitted screening information for the mechanical equipment on the building roof top. The provided plan was prepared by Degiaimo Group Architects; sheet A-3.0, Proposed Exterior Elevations, dated February 21, 2017, last revised March 23, 2018. The applicant also submitted a copy of a catalog offering the colors and types of screening, Louver Products Catalog; Architectural Louvers. The Board found that the roof top screening would be Dove Grey color, or equal. The applicant also noted that due to the size and weight of the roof top mechanicals, the units needed to be spread out over the surface of the roof, rather than in the center as requested by the Board. The Board approved the proposed roof top screening and location of the mechanicals, as presented.

A motion was made to adjourn the meeting by Deborah Stuhlweissenburg and seconded by Andrew Andrews and agreed by all in attendance at 8:30 p.m. The Decisions on the above hearings, which Decisions are made by the Board before the conclusion of the meeting, are mailed to the applicant. - **1.** The Board found that the proposed wall signage would consist of the following:
  - Light box sign, internally illuminated with LED lights.
  - The dimensions of the sign are as follows: 48" height by 108" width by 8" deep.
  - The sign face would be white Acrylic with the Bank logo in Blue, as noted on the submitted plan.
  - The Sign would be affixed to the exterior wall
