Item: ROCKLAND HOMES FOR HEROES (O-2387A)

Variance for lot area to permit the renovation of two buildings into fourteen new housing units, with twelve one-bedroom units and two two-bedroom units, as part of the Rockland Homes for Heroes to house Veterans. The parcel is located on 8.16 acres in the R-15 zoning district.

East side of Western Highway, opposite Gregg Court and Independence Avenue

Reason for Referral:

Western Highway (CR 15)

The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

*Recommend the following modifications

- 1 A review must be completed by the County of Rockland Highway Department, any concerns addessed, and all required permits obtained.
- 2 A review must be completed by the County of Rockland Department of Health, any comment or concerns addressed, and any required permits obtained.
- 3 Map note #10 is incomplete. The sewer district shall be recorded as Orangetown, as stated on the Land Use Board Application. In addition, map note #13 incorrectly states the plan is subject to General Municipal Law Sections L & N. As this is a site plan application and not a subdivision, this should be corrected to Sections L & M.

The review undertaken by the Rockland County Planning Department is pursuant to, and follows the mandates of Article 12-B of the New York General Municipal Law. Under Article 12-B the County of Rockland does not render opinions, nor does it make determinations, whether the item reviewed implicates the Religious Land Use and Institutionalized Persons Act. The Rockland County Planning Department defers to the municipality forwarding the item reviewed to render such opinions and make such determinations if appropriate under the circumstances.

In this respect, municipalities are advised that under the Religious Land Use and Institutionalized Persons Act, the preemptive force of any provision of the Act may be avoided (1) by changing a policy or practice that may result in a substantial burden on religious exercise, (2) by retaining a policy or practice and exempting the substantially burdened religious exercise, (3) by providing exemptions from a policy or practice for applications that substantially burden religious exercise, or (4) by any other means that eliminates the substantial burden.

Proponents of projects are advised to apply for variances, special permits or exceptions, hardship approval or other relief.

Pursuant to New York State General Municipal Law §239-m(6), the referring body shall file a report of final action it has taken with the Rockland County Department of Planning within thirty (30) days after final action. A referring-bedy-which acts contrary to a recommendation of modification or disapproval of a proposed action shall set forth the reasons for the contrary action in such report.



- 1. This office must approve plans for the sewage disposal per Article IV, Section 4.2.1 of the Rockland County Sanitary Code. Formal application is to be made. A copy of the sanitary sewer analysis is to be submitted directly to this office for review.
- 2. Application is to be made to the RCDOH for review of the stormwater management system for compliance with the County Mosquito Code.
- 3. In accordance with Article 13.8.1 of the Rockland County Sanitary Code, all multiple dwellings with three (3) or more rental units and all rooming houses must register and obtain a Multiple Dwelling Rental Certificate from Rockland County Health Department Rockland Codes Initiative (RCI) prior to occupancy.
